



Terms of Competition

- ◆ **Subject of the Competition.** PERIPATOS PC (further on "Organiser") launches a competition entitled "Stay Safe!" (hereinafter "Competition").
- ◆ **Right to Participate in the Competition.** Eligible to participate in the Competition is everyone over 18 years old.
- ◆ **Exclusion of Participants.** From this Competition are excluded those who fall under the following circumstances: a) the company's employees, b) those who use a nickname or unofficial name in the Form of Participation making it impossible to verify identification. Exclusion can take place at any stage of the Competition even during the Gift Delivery phase.
- ◆ **Duration of the Competition.** The duration of the Competition is set from Monday, 30th of March 2020 (hereinafter referred to as 'the Start of the Competition'), until Friday, 3rd of April 2020 at 23.59. (further called "End of Competition").
- ◆ **How to Enter the Competition.** Those who wish to participate in the Competition should: Properly solve the 5 puzzles that will be published on the Organiser's website (<https://peripatos.net/>) daily from the Start till the End of the Competition and register themselves on the Form of Participation until 3rd of April 23:59 as published on the Organiser's website the same day (03/04/2020).
- ◆ **Gifts.** Competition Prizes (hereinafter referred to as "Gift") will win 5 entrants with the right to bring one more person over 18 years of age. **The gift is:** participation in a treasure hunt game that will take place in a public space (park, square) in Athens, of 2 hours duration, designed by the Organiser. The event will take place after the uplifting of the traffic restriction and with the official assurance of the responsible authorities that socialising is again permitted and safe. The above gift is specific, not exchangeable or redeemed for money or any other product or any other way. The Organiser is not liable for covering transportation and subsistence expenses in case of non-residents of Athens or any other expenses beyond the design and provision of the gift service. Accepting the Gift of the Competition, the Winners allow the Company to disclose their name to any activity of the Competition through public relations and media.
- ◆ **How the Competition Winners are selected.** There will be a draw. The draw and the winners announcement will take place on 04/04/2020.



- ◆ **Information on the award - Receipt of the Gift.** Details of the Winners of the Competition will be announced on the Website and Social Media of the Organiser, the winners will be notified by the Organiser by phone, message or email. In case that it has not been possible to communicate with the winners of the Competition within three (3) calendar days of being sent to him / her for any reason, such person shall forfeit his / her right to the Gift.
- ◆ **Responsibility.** The Organiser shall not be liable in the event that for any technical reason it is impossible to obtain and register participation in the Competition. In any circumstance, the Organiser's liability will be limited to acts or omissions of wilful or gross negligence and will in no case extend to incidental or force majeure events.
- ◆ **Publicity.** The Terms of the Competition are posted on the website
- ◆ **Personal Information.** Details of Participants are collected by the Organiser for the purpose of conducting the Competition. Participation in the Competition constitutes the consent of the participants to maintain and use the above information for informational purposes only. Each participant has the right of access to the data concerning him / her and may at any time request their modification or deletion from the corresponding archive by letter to the Competition Organiser. In addition, the Organiser may, upon delivery of the Gift, ask the winners for further information.
- ◆ **Revocation of Notice - Modification of Terms.** The Organiser is entitled to revoke the notice of the Competition or modify these terms and conditions (including the duration of the Competition and the dates of the draws and prizes), by notifying via the Website, at the date of the withdrawal / modification of that date and of the relevant information.
- ◆ **Acceptance of the terms.** Participation in the Competition implies the unconditional acceptance of these terms and the express declaration of the Participants that they are solely responsible for their own participation and that they do not face any health problems which should prevent them from participating in the Competition.
- ◆ **Modification of conditions.** The Organiser has the right to modify the terms and conditions at any time during the Competition.
